- Consumer Notice: This form is not a contract, and it does not create any business relationship or obligations to People Centric Real Estate. Like the HIPPA form at the doctor's office this form is a state required disclosure. It informs you of privacy and confidentiality issues and highlights how a real estate agent or broker is required to act.
- **Listing Agreement:** This form is used to confirm that we agree to work together to find a ready, willing, and able buyer for your home, as well as outlining our duties to you. This form is not required to meet with you to discuss real estate, however when you are ready to list your property we will strive to ensure that all showings occur with only the most qualified buyers for your property as outlined below.
